

**ORDINANCE NO. 286
SECOND READING**

**ADOPTING THE AMENDMENT OF THE CITY CODE OF THE CITY OF
HAWKEYE, IOWA, 2020, BY AMENDING PROVISIONS PERTAINING TO
COMPENSATION FOR THE MAYOR**

BE IT ENACTED by the City Council of the City of Hawkeye, Iowa:

SECTION 1. SECTION MODIFIED. Chapter 4: SALARIES OF MUNICIPAL OFFICERS, Section 2-4-2 of the City Code of Ordinances of the City of Hawkeye, Iowa, 2020, is repealed and the following adopted in lieu thereof:

2-4-2 MAYOR. The mayor shall receive an annual salary of two thousand four hundred dollars (\$2400.00) per year, and twenty-five dollars (\$25.00) for each Council meeting attended, payable annually. Pay on a per meeting basis does not apply to work sessions attended outside of regular or special council meetings.

(Code of Iowa, Sec. 372.13(8))

SECTION 2. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication, and at the commencement of the term of office of Mayor beginning January 2024, as provided by law.
